## *NIFDI Offers 3 Virtual Academies!*

NIFDI was forced to cancel the National Direct Instruction Conference, but there will still be some virtual trainings this summer. During the week of July 27-31, NIFDI will host 3 virtual training sessions.

- \* Direct Instruction Coaching
- \* Behavior Management Essentials
- \* Administrative Leadership in a Direct Instruction School

These interactive sessions will run for 4 days, 3 hours a day. Registration and complete descriptions will be available the week of June 8th.

The training in these sessions is focused on skills and information used in the traditional, face-to-face context. However, there will be some information provided on how to make adjustments for the virtual, live setting.



## Additional Distance Learning Webinars Coming this Summer!

With schools shut down due to the COVID-19 pandemic, NIFDI has tried to meet the needs of educators by offering webinars that will assist in understanding the considerations for delivering Direct Instruction in a variety of methods, such as live presentation via Zoom (or other platforms), pre-recorded lessons, and packets of material for students to work through. Our training development staff is busy planning two additional webinars.

The first is a followup to the Reading Mastery Signature Edition Language webinar we presented earlier in May. This followup session will be free to those that attend the first event. It will contain specific information about tasks that must be modified for live, virtual instruction and also look at effective techniques for checking for mastery of material presented in recorded lessons. The second will be a similar webinar for those teaching Reading Mastery Signature Edition Reading K and 1.


